

A project to support land clarification within designated areas

February 2021



For generations, many residents in African Nova Scotian communities have faced barriers to getting clear title to the land they live on. That is why the Land Titles Initiative project was created in 2017 to help clarify the land title process.

The Land Titles Initiative (LTI) is a government-led commitment to help residents in the eligible communities of North Preston, East Preston, Cherry Brook/Lake Loon, Lincolnville and Sunnyville get clear title to their land — **at no cost**.

LTI helps residents in eligible communities:

- get clear title to their property (Land Title Clarification Act)
- migrate their property to the new land registry system (Land Registration Act)
- complete estate administration when someone dies (Probate Act, Intestate Succession Act)

Updates

As of January 1st, 2021, more than **527** applications have been received and over **188** land parcels have been cleared. Two more Certificates of Title have been issued in North Preston.
